

✤ A BRIEF HISTORY OF THE COLLEGE

A proposal to setup a college to impart general Higher Education to the people residing in the newly urbanized southernmost part of the town was mooted by some eminent educationists in the early part of 1970. A committee of some leading citizens was formed to start the college with the name New Silchar College in nearby Netaji Girls' High School from the academic session of 1971. The need for an Institution of Higher Education in this area began to be generally felt, and two "Sebaiets" of the Estate of the deity Radhamadhab, Late Rajanikanta Saha and Smt. Sefalikana Saha, wife of Lt. Hrishikesh Saha came forward to donate a plot of land, measuring 1¹/₂ acres for the purpose, on condition that the college be named after the deity Radhamadhab. So, the college under the name and style Radhamadhab College formally came into existence on 31st May, 1971. Gauhati University granted affiliation to the college upto Degree of Bachelor of Arts in the year 1971. In 1983 the Govt. of Assam extended to the College grants in aid status. The UGC granted its recognition (2f and 12B) in 1992 and since then the college has been receiving UGC financial assistance for various development projects. The college celebrated its Silver Jubilee year in 1996. Since its inception, the University toppers of both Gauhati University and Assam University have added fresh laurels to its achievements and added many a feather to its cap.

COLLEGE

Surrounded mostly by suburbs, the College is situated in New Silchar area about 2 K.M. away from the main centre of the city, in Silchar-Aizawl National Highway. All types of vehicles ply on the road and there is no problem to reach the college within a few minutes from any part of the city.

♦ AFFILIATION AND RECOGNITION

Started as a single faculty of Arts in 1971, the college was granted affiliation first by Gauhati University in 1971 for the award of degree in Bachelor of Arts and then it came under the jurisdiction of Assam University Silchar (A Central University) in 1994 when it came into existence. The Govt. of Assam granted the College grants in aid status in 1983. The college also got its registration in 1983 under Registration of Societies Act of 1860.

✤ ACCREDITATION

Radhamadhab College is the first college from Southern Assam and first among the affiliated colleges under Assam University to be accredited by National Assessment and Accreditation Council (NAAC). The Executive Committee of the NAAC on the recommendation of the duly appointed Peer Team declared the College Accredited with C+ Grade. The college was reaccredited in 2016 (Second cycle) with Grade B. Right now, we are marching towards the 3rd Cycle of NAAC accreditation. The College has already submitted the SSR for third cycle of accreditation.

✤ MANAGEMENT OF THE COLLEGE

The college is managed by a body of respectable personalities of the city, under the name and style "Governing Body", constituted under the provision of Assam Non-Government College Management (Amendment) rules, 2009. Though the body is permanent in nature, but the tenure of most of the members in the body is generally three years. The body is composed of persons nominated by the Govt. of Assam from among the panels of personalities which include in it donor member as well as representatives from teaching, non-teaching staff of the college and guardian members. The University nominates its representative to the body.

VISION

The ultimate goal of the college is to make the institution "a centre of excellence in the field of Higher Education". To achieve this goal, systematic approach, introduction of innovative academic programme and planned approach in infrastructural development adopted in recent years in this institute to produce trained and skilled student for betterment of the society. The college has also introduced meaningful co-curricular activities to generate a sense of discipline, ethical and moral values in the students and centre for extension activities to involve students in community service and to develop a sense of sharing. Participation in literary and cultural competitions definitely brings out the talent and helping them to develop into whole personality so as to enable them to contribute towards nation building.

However, the college feels that, it is a gradual ongoing process and need co-operation from all quarters of the society.

H.S. GUIDLINES

1. Two year Higher Secondary Courses affiliated to Assam Higher Secondary Education Council and is governed by the rules and regulations of Assam Higher secondary Education council.

The course comprises of two parts, H.S. 1st year and H.S. 2nd year or Final year. The scheme of study for H.S. in Arts stream is as follows:

A candidate of H.S. Programme of the council shall have to offer the following-

- (a) Core subject
- (i) English 200 marks (with two papers of 100 marks each)
- (ii) M.I.L. (Bengali, Manipuri, Mizo, Bodo, Assamese, Hindi, Khasi, Garo, Hmar)
 - 200 marks (with two papers of 100 marks each)

(100 marks in the H.S. First year examination and 100 marks in H.S. Final year Examination)

N.B- Except for Bengali & Manipuri, the rest of the subjects If opted for are to be student privately by the candidate.

- b) *Elective subjects*
 - (i) Three Elective subjects, each of 200 marks (100 marks in H.S. First year Examination and 100 marks in H.S. Final year Examination)

Subject offered: Adv. Bengali, Adv. Manipuri, Political Science, Economics, Education, Logic & Philosophy, History, Swadesh Adhyayan.

(ii) In addition to the three Elective subjects, a candidate shall have the option to offer a fourth elective subject from the above of 200 marks. (100 marks in H.S. First year examination and 100 marks in H.S. Final year Examination).

2. Pattern of Examination:

- (a) First Year Examination at the end of First year class to be conducted by the council / College
- 1. English 100 marks X one paper = 100
- 2. MIL 100 marks X one paper = 100
- 3. Elective Subjects 100 marks each X 3 paper = 300

- (i) First year examination shall be held within March every year.
- (ii) The result of the First year examination shall be declared on the basis of the criteria as fixed by the Council/College from time to time.
- (b) H.S. Final Examination shall be held at the end of second year to be conducted by the council.
- 1. English 100 marks x 1 paper = 100
- 2. MIL/ Alt. English 100 marks x 1 paper = 100
- 3. Elective Subjects 100 marks each x 3 paper = 300
- (i) H.S. Final examination shall be held in February/March every year.
- (ii) The result of H.S. Final Year Examination shall be determined on the basis of the marks obtained in the H. S. Final Examination only.
- 3. Qualifying (Pass) Marks: A student shall be declared pass only when he/she passes in each of the core and (three) elective subjects. The pass marks shall be 30% in each paper. In case of candidate offering four elective subjects, the marks for these three subjects where the candidates' performance is better shall be taken into account for determining pass, rank, division, distinction and star mark. The marks secured in the fourth elective subject (with the poorest performance) will, however, be indicated in the mark sheet. The marks secured in the fourth elective subject will not be taken into account for awarding rank, division, distinction.
 - A candidate obtaining 60% marks will be placed in First Division.
 - A candidate obtaining 45% or more but less than 60% marks will be placed in Second Division.
 - A candidate obtaining less than 45% marks will be placed in Third Division.
 - A candidate obtaining 80% or more marks in any subject will be declared to have secured DISTINCTION in that subject.
 - A candidate obtaining 75% or above of the total allotted marks will be declared to have secured "STAR MARKS".

PROGRAMME OF STUDY UNDER FYUG: FOUR-YEAR DEGREE COURSE - SEMESTER SYSTEM (Under NEP 2020)

B.A. and B.Com.

(Relevant abstract of the General Guidelines & Regulations of Assam University)

PROGRAMME OF STUDY UNDER FYUGP:

The programme of study to be called as Four-year Under Graduate Programme (FYUGP) under NEP 2020 and shall be a 8-semester programme of 4 (Four) years duration.

Primary Guidelines for admission to Degree 1st semester consequent upon implementation of NEP-2020 by the Assam University, Silchar.

Assam University has implemented NEP-2020 from the session 2023-24 for UG courses in affiliated colleges with the following guidelines:

- 1. UG curriculum for Colleges affiliated to Assam University shall be a four year UG programme (FYUGP).
- 2. UG programme under AU shall be of four year duration with lateral exit and entry option at various level; viz. Exit after one year (two semester) with <u>Undergraduate Certificate</u>, exit after second year or four semester with <u>Undergraduate Diploma</u>, exit after third year or six semester with <u>Three Year Bachelor's Degree</u> and exit after four year or eight semester with <u>Bachelor's Degree (HONOURS/Research)</u>.
- 3. Curriculum structure as per NEP-2020 for colleges affiliated to AUS is comprising of the following courses-
 - DSC: Discipline Specific Core.
 - DSM: Discipline Specific Minor.
 - IDC: Interdisciplinary Courses.
 - AEC: Ability Enhancement Courses (Language MIL (Bengali, Manipuri) & Alt. English).
 - SEC: Skill Enhancement Courses.
 - VAC: Value Added Courses (Common)
- 4. a) DSM is two types for each subject first minor and second minor.
 - b) Students shall take two DSM subjects related to his/her discipline from cluster of subjects provided by the College/University.

c) For Three Year UG programme DSM-101(3), DSM-201(4), DSM-251(3) and DSM-301(3) =13 credits should be the first minor subject while DSM-151(3), DSM-252(3), DSM-302(3) and DSM-354(4) = 13 credit should be second minor subject. For FYUG programme DSM-401(4) should be first minor subject and DSM-451(4) should be second minor subject.

5. Interdisciplinary Courses (IDC) shall have three (03) baskets viz. Social Science (SS), Humanities (HN) and Commerce & Management. Student may opt for any one from these 04 baskets in each of I, II and III semesters. Bunching of subjects in each basket shall be as per table below.

1	Social Science (SS)	Political Science, History, Economics, Philosophy, Education, Library & Information Science.
2	Humanities (HN)	English, Bengali, Manipuri
3	Commerce & Management	Commerce

- 6. IDC courses opted shall remain same for all three semesters. Semester wise change of IDC is not allowed.
- 7. DSC, DSM and IDC cannot be the same subject.
- 8. For VAC 151 (EVS) there shall be no practical component.
- 9. For Research with Honours students, DSC-451 paper shall be Research Methodology and content of this course shall be the same across the subjects and across the disciplines.
- 10. Any student interested to opt for Honours with Research in fourth year should have 7.5 CGPA upto third year or 6th semester without any arrear.
- 11. For only Honours degree there shall not be any CGPA restrictions, but students with arrear papers shall not be allowed to move 4th year in any case.

- For only Honours degree in 8th semester in lieu of project/dissertation, students shall have the option to take three additional courses as DSC (DSC-452.453 & 454) which will be equal to 12 credits in total.
- 13. For AEC there shall not be any internal examination and the total marks for AEC examination (ESE) shall be 50 with two hours examination duration.
- 14. <u>SEC shall have to be opted from either DSC or DSM.(SEC should be</u> offered same subject as the student opted DSC wherever available)

ON LINE ADMISSION PROCESS FOR THE SESSION 2024-2025

Students can apply for admission in this institution through DARPAN Portal of Assam Higher Secondary Education Council. Link for student registration is https://darpan.ahseconline.in/ Visit DARPAN portal www.darpan.ahseconline.in for required necessary documents and registration guidelines.

In this regard, students are requested to note the following:

- 1. All candidates have to generate Unique ID through the link https://dheonlineadmission.amtron.in/sp/
- 2. Maximum 02 (two) years of gap (if any) will be allowed subject to production of valid and appropriate gap certificate.
- 3. Only Income certificate issued by the Circle Officer will be accepted for taking admission under Fee Waiver Scheme of Govt. of Assam.
- 4. Candidates seeking admission from any other board/council (other than SEBA) will have to submit Migration Certificate.
- 5. It is mandatory for the students to have an email ID with their own name and phone number (An OTP will be sent to this mobile number for login into the admission portal) with whatsApp.
- On completion of online admission process, the final list of the students will be notified in the College Notice Board and website.
- 7. For uniform, students are directed to contact the College Office and see the website.

FYUGP

The admission form fill up process will be on-line through SAMARTH e-Gov. Portal. The Commencement of Admission will be notified through College Website and Daily News Paper.

Procedure of online form Fill-up and Admission

- 1. As per notification of Assam University, No. AUD/CDC/CUET-2024/47, Dt. 15/03/2024 issued by the Registrar, AUS, the admission in Four Year Under Graduate (FYUG) courses will be through CUET (UG) from the current academic session. However, the vacant seats (if any) may be filled up with non-CUET candidates by following standard admission process of the College.
- 2. Candidates have to fill up and submit admission forms online through SAMARTH e-Gov. Portal. (www.assamadmission.samarth.ac.in). Link will be made available in the College Website- www.rmcollege.org
- 3. Merit lists (Course wise) will be uploaded online before admission.
- 4. All the applicants have to be present physically for document verification and necessary admission process.
- 5. A candidate must produce the following documents in original along with the self attested photocopies-
 - Mark sheet and Admit Card of the last qualification examination.
 - Age proof certificate
 - Two copies of recent passport size photographs.
 - Cast certificate from competent authority (Wherever necessary)
 - Income certificate from Circle officer (Wherever necessary)
 - An undertaking from the applicant and also his/her guardians that the applicant will not resort to ragging, in any form, must be submitted in the prescribed format at the time of admission.
- 6. Students passing the qualifying examination (10+2) earlier than the current year will have to submit a gap certificate (Max. 3 years).
- 7. All admissions are governed by the College admission rule.

A) CLASS SCHEDULE:

Academic session of H.S. class will tentatively begin from June and continues till February of the next calendar.

Holidays and vacation are declared strictly in accordance with Assam University rules of Holiday.

Classes of all courses (H.S & FYUGP) generally begin at 9-00 A.M. and continues till 4-30 P.M. from Monday to Saturday. Students are required to collect their class schedule just before the beginning of the first day of class. Class schedule of all classes is displayed on the college NOTICE BOARD.

N.B.: Students are to come to College with neat and clean College Uniform.

B) ATTENDANCE:

Students of all classes are required to attend lectures of respective classes each of 45 minutes duration. 75% attendance of lectures delivered in each subject is compulsory for all students to be sit for the Final Examination. Students attending less than 75% of lectures are not allowed to sit for the Final Examination of University or Council.

Examination Guidelines:

- 1. Students securing highest CGPA (above 6.0) and with no back paper shall be allowed to change his/her core course once only, after completion of second semester. However, if a candidate desires to make one of his/her minors to core then automatic change in the minor should be done as same subject cannot be opted as both core and minor. Also change of core may be allowed only within allied subjects.
- 2. 7.5 CGPA should be obtained by a student up to 3rd year for opting Honours with Research Degree in 4th year. However, for only Honours degree there shall not be any CGPA restriction. But students with arrear paper shall not be allowed to move to 4th year in any case.
- 3. Evaluation of 3 and 4 credit courses shall be out of 100 marks and that for 2 credit course shall be out of 50 marks.
- 4. IDC courses opted shall remain same for all three semesters. Semester wise change of IDC is not allowed.
- 5. For AEC courses, there shall not be any internal exam. Total Marks for AEC examination shall be 50 with two hours examination duration.
- SEC shall have to be opted from cither DSC or DSM. Evaluation method of SEC for Arts and commerce shall be 50 (End Semester Theory)+20 (End Semester Practical/Project/Field work) + 30 (internal test of which 20 for test and 10 for attendance).
- For EVS (VAC-151) evaluation method shall be 70 (End Semester exam)
 + 30 Internal/Assignment. Marks for Internal test shall again be divided to 20 for written test and 10 for attendance.
- 8. Evaluation method for VAC-101 (with practical) shall be same as that of SEC (with practical) and that of VAC-101 (Without practical) shall be same as VAC-151.
- 9. EVS in VAC-151 should be of 100 level and EVS included in Natural Science Basket as IDC should be of 200 level.

- 10. Publication/Presentation of papers out of Research Project Dissertation carried out in VIII semester is not mandatory. However, the project shall have to be presented before Departmental Research Committee and in presence of an external examiner during end semester examination. Total marks for the project shall be 300 of which 90 shall be internal and 210 is for end semester examination. Out of 90 marks as internal, in case of Dissertation/Project, there shall be three progress reviews and each review shall be of 30 marks. Marks obtained by a student in each of the review shall be notified immediately. Review of progress shall be done by concerned supervisor in presence of Departmental Research Committee.
- 11. For all other courses evaluation method shall be of 70 marks (for End Semester Examination) and 30 marks (for Internal Examination). Marks for Internal test shall again be divided to 20 for written test and 10 for attendance.
- For Subjects with practical's DSC-152, DSC-253, DSC-303, DSC-354 and DSC- 404 shall be practical with 100 marks. Practical examination shall be held in presence of External Examiner.
- 13. For Subjects with practical DSM-251 shall be practical for first minor and DSM-351 shall be practical for second minor. Marks for practical examination shall be 100 each and examination shall be held in presence of External Examiner.
- 14. For VAC 151 (EVS), shall not have any practical component.
- 15. For opting DSC and DSM combination, clustering of subjects shall be as per ANNEXURE-III. DSC from one cluster and DSM from other cluster is not allowed. DSC, DSM and IDC cannot be the same subject.
- 16. All DSM courses shall be stand alone and students can select first minor subject and second minor subject according to their choice keeping total requirement of 17 credit for each minor but they cannot change the code of minor papers viz. one student of Physics (Core) may have Chemistry as first minor in DSM 101 and Mathematics as second minor in DSM 151. But the other student of Physics (core) may have Mathematics as first minor in DSM-101 and Chemistry as second minor in DSM 151.
- 17. For Research with Honours students, DSC-451 paper shall be research methodology and content of this course shall be same across the subjects and across the disciplines. However, for other students, DSC 451 will be a usual 500 level paper.
- 18. Any student interested to opt for Honours with Research should have 7.5 CGPA up to third year without any arrear.
- 19. In lieu of MIL, Alternative English may be opted by a student.

- i) If after admission a student has to give up studies during the course, he/she may do so on writing to the Principal after clearing all dues for the session Discontinuance of studies without notice is liable to entail payment of all fees up to the end of the academic session.
- RMC tries its best to inculcate in the-students a regard for moral values. Along with academic pursuit, the motto of the college is to instill in the students the sense of self confidence, discipline, good conduct and toleration. No act of indiscipline, insubordination, disrespect to any teacher, employee, to any religion or community is tolerated and appropriate penal measure is taken leading even to issuance of forced T.C.

- iii) Any student adopting unfair means in any internal or university examination(s) is liable to be debarred from appearing at the remaining examinations.

CENTRAL LIBRARY (BIPIN CHANDRA MEMORIAL LIBRARY

The Central Library of the college christened as 'Bipin Chandra Memorial Library' aims to support the academic programmes offered by the parent body and to provide better collection and services to support the academic requirements of the students and the teachers. The library building under UGC VIIIth Plan on the first floor of the Central Block of the college is housed with 19638 books and 30 journals and magazines, along with a number of leading national and local newspapers. The library has a good Reference Collection including Dictionaries, Encyclopedias, Biographies, Educational Philosophies, Research Methodology, North-East, Religion, Literary Works, Bound Question Papers and a 'Special Repository Centre for Barak Valley', to collect books related to the history, culture and literary heritage of the region.

The library has created an online Database of its total collection using SOUL, 3.0 and is fully automated with computerized processing and circulation services. An Online Public Access Catalogue (OPAC) has been created by the library, through which books can be searched (with keywords) through computer easily, giving exact location of the book in the library. The library provides various modern facilities like Bar code-enabled computerized Library Card, Internet, Reprography, Inter-library Loan, Online Searching, E-Resources, Consortium-based Services, etc. The library has the facility of Departmental Library for each department, having a separate collection on each subject. The library is also enabled with the facility to access the electronic resources of INFLIBNET Centre, UGC, by registering through the N-LIST Programme (National Library and Information Services Infrastructure for Scholarly Content) of UGC, including 2,100 electronic journals, 51,000 electronic books and several bibliographic databases, which can be accessed by the students of the college through Internet Browser with the Username and Password of the college. The library has established online association with the British Council (Library and Information Services), Kolkata, to avail various facilities like accessing Books and Periodicals, DVDs and CDs, Online Resources, Document Delivery Service, etc. of the British Council, through the Institutional Membership Cards and Login ID and Password of the college. The library maintains a separate web page in the official website of the college, which enables the library to offer its services and to tell its story to its users. Details of library holdings and library services are incorporated in the webpage (Address: www.rmcollege.org/library).

The library added a new feather to its cap by introducing the Digital Library Section in 2016. The Digital Library of the college has been initiated since 2013 with the installation of a Digital Library Server with 1 TB storage capacity along with access in the client machines with unique login credentials for students and faculty. A number of downloaded digital objects have been stored in the Digital Library along with educational CDs and DVDs, Photo Gallery of the college, etc. Recently a Digital Library Institutional Repository has been created for storing digitized copies of Prospectus, College Magazines, Newsletters, Question Papers, E-book etc. Also Smart Attendance System for library visitors and Digital Display Monitor have been installed in the library.

A spacious reading room has been provided for the students, with access to newspapers and journals. They are also enabled with free Internet facility for their learning purpose. The library also provides Career Information Service to the students with access to competitive magazines and Employment News in the library, and also displaying various career-oriented information on the Notice Board of the library. The library acts as a centre providing in-house training and practical sessions to the students of DLIS (Diploma in Library and Information Science) course run under the Self-Financing Cell of the college. A Library Orientation Programme is conducted every year to train the students about use of library and library resources, and also as to how to access the electronic resources available in the library. Besides the library has

a Book Bank for the financially challenged students, where students can avail the facility of borrowing books for the whole session.

The library is advised and supported by the Library Committee under the aegis of IQAC of the college, to advice in matters of development and management activities of the library. Library activities like Book Exhibition, Library Best User Award, Library Literacy Programme, Publication and release of Library Newsletter 'Informania', Guest Lectures and Awareness Programmes, etc are being organized with the support of the Library Committee.

The library is open from 9.00 A.M. to 5.30 p.m. on all working days. Students will be issued Smart Library Card from the library at the beginning of the session. For more details students may visit the library.

RMC annual function is one such activity in which students get opportunity to project themselves in the fields which interest them. RMC has created ample scopes of value based extracurricular activities in which students can participate for practicing and developing value based education. 

✓ Academic Monitoring Cell

About the Cell - Guidelines and Functions:

The Academic Monitoring Cell shall be vested with the functions necessary to ensure quality enhancement of academic life of the college involving both the external and internal activities. The Cell shall take necessary measures/ recommended measures/adopted measures for academic development and healthy practices in the college. The academic development activities incorporate (organizing workshop, seminar, symposia, lectures for involvement of teaching-learning mode; use of learning mode to meet learners' need; to evolve method for improvement of pass/drop-out rate; development of sense of social, personal, cultural and ethical values among students; to improve progression rate; to offer appropriate remedial coaching to slow learners; to develop sense of greater responsiveness to community need; to encourage teachers to take up small research/ project/ survey on community problems funded by various funding agencies, use of new technology in teaching and cocurricular activities, arranging interdepartmental lectures for enrichment of students' knowledge; establishment of linkage with national/ international/ state level organizations for training research etc. for students and teachers; involving and motivating students in various academic activities like debate, seminars etc. organized inside or outside the college and such other innovative technique necessary for the improvement of quality in teaching-learning experiences; academic life and healthy practices in the college.

With these purposes in view, the College has introduced a 'mechanism' by initiating 'Academic Monitoring Cell' with the purpose of accomplishing the ultimate goal of the College.

Mentor-Mentee Program (under Academic Monitoring Cell)

Radhamadhab College considers the Mentor-Mentee Program as one of the most essential elements of teaching-learning process. The college has adopted and implemented the program with an intention to provide a healthy environment for the students. The students are encouraged to interact with their respective mentors and are accordingly counselled at regular intervals. The students receive academic, emotional and mental support when in need and as per analysis during the counselling sessions.

In this regard, a few policies, common to all, are adopted and practised by each of the faculties from all the department to ensure proper functioning of the Mentor-Mentee program:

Each department is instructed to take mentees from their respective DSC/Honours subject, on the basis of the student's requirement for a mentor.

- The list of the mentees is prepared on the basis of the following criteria:
 - i. Socio-economic background of the student.
 - ii. Merit of the student.
 - iii. Result of the previous semester of the student.
 - iv. Emotional and mental instability (if any) of the student.
- On preparation of the list, keeping in view the above mentioned criteria, each department is supposed to hold a departmental meeting, wherein the faculty members, depending on the number of permanent staff, should be assigned mentees, not more than 20 in number.
- The faculty members should maintain records of regular counselling session(s) with the students, wherein their academic progress and mental health be monitored.
