



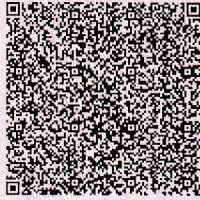

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made on day of 17th March, 2023 between Radhamadhab College, Sonai Road, Silchar, Cachar, Assam affiliated to Assam University and registered under Section 2F and 12 B of UGC Act, 1956 represented by the Principal, who is duly authorized to execute this agreement herein after referred as 1st Party, engaged in imparting education.

And

N.C.Paul Memorial College, Jogipara, Near NIT, P.O. Silchar, Pin-788010, Cachar, Assam affiliated to Assam University, Silchar represented by Principal, who is duly authorized to execute this agreement, herein after referred as 2nd Party, engaged in imparting education.

PURPOSE

- To build an academic relationship between the 1st Party and 2nd Party for the benefit of the students.
- To find out the weaker areas in the academic system and improvise upon it to improve the quality of education.

3. COMMITMENTS

- i. Both the institutions will go for collaborative teaching.
- ii. Both the institutions will share the manpower.
- iii. Both the institutions shall jointly work to enhance the learning levels of children in the school.
- iv. The 1st Party shall try to assist the 2nd Party in their teaching-learning process by giving special support in those subjects having less number of teachers.

4. DURATION, TERMINATION AND AMENDMENT

- i. The validity of this MoU will be for a period of 02 (two) years with effect from the date of signing of this MoU. The MoU may be renewed on mutually agreed terms between the Parties.
- ii. Either Party may terminate this MoU by giving 06 (six) months advance notice in writing to the other party.
- iii. The provisions of this MoU may be amended at any time with the mutual consent of the Parties in writing.

iv. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of the amendment, termination and expiration unless otherwise agreed upon between the parties.
