1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

A BRIEF HISTORY OF THE COLLEGE:

A proposal to setup a college to impart general Higher Education to the people residing in the newly urbanized southern most part of the town was mooted by some eminent educationists in the early part of 1970. A committee of some leading citizens was formed to start the college with the name New Silchar College in nearby Netaji Girls' High School from the academic session of 1971. The need for an Institution of Higher Education in this area began to be generally felt, and two "Sebaiets" of the Estate of the deity Radhamadhab, Late Rajanikanta Saha and Smt. Sefalikana Saha, wife of Lt. Hrishikesh Saha came forward to donate a plot of land, measuring 1½ acres for the purpose, on condition that the college be named after the deity Radhamadhab. So, the college under the name and style Radhamadhab College formally came into existence on 31st May, 1971. Gauhati University granted affiliation to the college up to Degree of Bachelor of Arts in the year 1971. In 1983 the Govt. of Assam extended to the College grants in aid status. The UGC granted its recognition (2f and 12B) in 1992 and since then the college has been receiving UGC financial assistance for various development projects. The college celebrated its Silver Jubilee year in 1996 and Golden Jubilee in the year 2021. Since its inception, the University toppers of both Gauhati University and Assam University have added fresh laurels to its achievements and added many a feather to its cap.

AFFILIATION AND RECOGNITION:

Started as a single faculty of Arts in 1971, the college was granted affiliation first by Gauhati University in 1971 for the award of degree in Bachelor of Arts and then it came under the jurisdiction of Assam University Silchar in 1994 when it came into existence. The Govt. of Assam granted the College grants in aid status in 1983. The college also got its registration in 1983 under Registration of Societies Act of 1860. The Commerce Stream of the College, though not yet been provincialised started in the year 2007.

Vision

The ultimate vision of the college is to make the institution "a centre of excellence in the field of Higher Education"" To achieve this goal. systematic approach, introduction of innovative academic programme and planned approach in infrastructural development has been adopted in recent years in this institute to produce trained and skilled student for betterment of the society. The college has also introduced meaningful cocurricular activities to generate a sense of discipline ethical and moral values in the students and centre for extension activities to involve students in community service and to develop a sense of sharing. The vision of the College is to encourage the students to participate in literary and cultural competitions with a view to honing their skills, focusing on their latent talent and helping them to develop into whole personality so as to enable them to contribute towards nation building. However, the College feels that, it is a gradual ongoing process and need co-operation from all quarters of the society. The College has setup before it twin objectives to provide the society and the nation with quality higher education and to contribute to the physical, intellectual, aesthetic and moral growth of the youths with a sense of commitment towards building a better tomorrow. The ultimate goal of the college is to make the Institute a centre of excellence in the field of higher education. To achieve the goal, the college aims at:

- 1. Providing the learners academic excellence in the respective field of study.
- 2. Preparing the learners for commendable career relevant to national need.
- 3. Preparing the students for life long learning by developing an appropriate learning style and aptitude among thern.
- 4. Instilling a sense of discipline, ethical and moral values so as to make the learners responsible and ideal citizen of the country.
- 5. Providing specialized skill-oriented courses at different levels.
- 6. Transferring Knowledge, skill and technology to the community through extension activities.
- 7. Exploring the innate creativity and talent of the learners and helping them develop into wholesome personality so as to enable them to contribute towards nation building.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

- The college caters to the educational needs of the socially and economically disadvantaged sections of the society.
- The ratio of the Students vis-à-vis full time teachers is 40:1

- Percentage of seats filled against seats reserved for various categories of students is more than the prescribed norms/rules.
- Among the currently filled up posts 17 out of 22 faculty members including Librarian have Ph.D as their highest degree.
- Majority of the teachers have NET/SLET or JRF.
- The student enrolment ratio has increased steadily during the last five years.
- A good number of students enroll themselves from the neighboring sates.
- The college has modern technological facilities, like Smart and Virtual Classrooms, Digital Display Notice Board, etc.
- The college has an active NSS Unit through which students engage in community service.
- Around 50% of the students studying in the college are female students, and the Women Cell of the college arranges various programs, trainings and activities with a view to aware and empower them.
- Initiatives are taken to ensure that majority of the academic and administrative works are digitized.
- A significant number of Self-Financing Courses like Diploma in Computer Application and Library Science, Certificate Courses in Cyber Security and Social Media Marketing, Certificate Course in Sanskrit Language, Beautician, Tailoring, Weaving etc. are conducted to enhance the skill-set of the students.
- Free health check-up of students and health camps are organized every year by the Health Care Centre.
- The NSS Unit of the College plays a proactive role in organizing different events which contributes to community participation.
- The college has a transparent mechanism for conducting internal assessment and has been an Evaluation Zone of External Examinations granted by the affiliating university for the last few years.
- The Library of the College is well equipped and well managed focusing more on digitization.
- The college has received grants from RUSA 2.0 amounting to Rs. 2 Crores and has qualified for receiving grants under PM-USHA.
- The College has received ISO certification on 1st August, 2023. (ISO 9001:2015)

Institutional Weakness

- Paucity of fund at both state and central level proves detrimental to the development of the college.
- Over the years it has been observed that majority of the students coming from vernacular medium and securing very low percentage of marks are admitted and subsequently fail to cope up with the higher level of studies.
- Infrastructural limitations regarding 2 Assam Type buildings.
- Though the students constantly forward a demand for a playground in the college, the college authority is constrained to provide the same due to lack of space. However, the IQAC of the college arranges playgrounds in the vicinity for conducting different sports events for the students.
- Narrow approach area of the college and regular complaints received from the locality regarding huge gathering in the lane.
- Frequent water logging in rainy season and flood water influx which obstructs entry into the college.
- Majority of the students hail from sub-urban areas and most of them belong to economically disadvantaged sections of the society, as a result they opt for part-time jobs which leads to low attendance in the classes.
- A good percentage of students come from other states, who often engage themselves in part-time jobs to meet their expenses and do not come to attend classes in the college.
- The non-provincialization of the fully functional Commerce stream, despite several attempts, is an area

- of weakness for the college.
- The college has limited availability of land area, which restricts its infrastructural development to a considerable extent.
- The non-availability of Science stream obstructs the college from catering to the needs of those students who wish to pursue their educational career in science and technology.
- The number of sanctioned posts for teaching staff of the college is insufficient compared to the enrolment percentage of students.
- The introduction and implementation of Fee-Waiver Scheme has led to not only loss of revenue but also has added to the woes of the college in general and the departments in particular in the sense that the students tend to shy away from the classes resulting in poor performance in examination.

Institutional Opportunity

- Catering to the need of rural students and students belonging to the other states and socially and economically disadvantaged section of the society, the College is constantly endeavoring to provide quality and technologically upgraded education to the students.
- There is an opportunity for increasing the GER (Gross Enrollment Ratio) of the students. Thereby, contributing to the state and national ratio.
- With the limited space available, the College under the able leadership of the Principal is trying to open up Science stream as well as pursue the matter relating to provincialisation of the Commerce stream.
- The introduction of NEP, 2020 has provided the College with an opportunity to introduce more skill oriented programmes/ courses and the College is vying for the same.
- There is an opportunity for the college to become a premier educational institution of the valley as the teaching staff of the college are all very experienced and qualified.
- By introducing more skill-based hands-on training sessions for students, employment opportunities can be created for them.
- The college has an opportunity to upgrade the existing IT facilities by introducing more Smart and Virtual classrooms.
- Communication skills of the students can be developed through soft-skill courses, like Functional English.
- More innovative self-financing courses can be introduced which will prepare the students for future job opportunities.
- The College aims at introducing more subjects and courses subject to the approval of competent authority.
- Owing to the diversity of the students, the College has opportunities in the arena of Sports and Cocurricular activities.
- Honing the skill of the female students (more in percentage than the male students) in the skill oriented programmes is definitely an opportunity for the students. It needs to be mentioned here that the College striving forward under the able leadership of an IQAC Coordinator who happens to be a Woman member of the College.
- Though the College has been granted the study centre of KKHSOU, the introduction of Bengali as a subject in KKHSOU would have considerably increased the number of enrolled students in the College.

Institutional Challenge

- As most of the students taking admission in the college are from socially and economically disadvantaged sections of the society, it is a challenge for the institution to improve their academic performance and make them excel in their studies.
- For the same reason, the institution feels that it is the responsibility of the institution to bring upliftment and holistic development in these backward students. Hence, it is taken as a challenge to create different avenues and opportunities for them to make them flourished and self-reliant with a secured future.
- As most of the students come from the outskirts of the town, they do not come to classes regularly owing to distnce from their residents. Hence, it is a challenge for the institution to attract them towards the college for regular classes.
- To manage more funds for ensuring infrastructural and other developments of the College.
- To dismantle the old assam type classroom buildings and convert into permanent RCC Building .
- To increase the intake seat capacity of the students
- To solve the problem of water logging in the adjacent area of the College campus.
- To solve the problem of narrow approach to the College Campus and to decrease the gathering at the time of start and end of classes.
- To have a permanent playground for the College which will eventually help the students to have a career in sports.
- To increase the scope of campus placement for the students.
- To bring on board the students coming from vernacular medium, who also happen to be from socially and economically backward community, and improve their academic performance.
- To make infrastructural advancements in the light of shortage of land area.
- To combat the problem of flood-water influx in the college campus during rainy season.
- To do away with the digital-divide which acts as an obstruction in ensuring that the students are at par with the rapidly changing technological world.
- To track and record the progression of pass-out students into either higher education or placement.
- To ensure permanent affiliation of the Commerce Stream of the College.
- To introduce the Science Stream in the College.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The institution ensures that curricular planning and implementation are done in an effective way and to facilitate the implementation process steps like organising faculty meetings at the commencement of each academic session by the Principal of the College, Departmental meeting at the beginning of the session for distribution of workload and preparation and distribution of Master routine, followed by preparation and distribution of departmental routines by the respective departments are done. Moreover, the IQAC takes a proactive role in the preparation of Academic Calendar. The calendar is duly approved by the Principal and scrupulously followed by the stakeholders of the institution. It needs to be mentioned here that during the last five years 18 add on/Certificate/Value added programs have been offered by the institution and a total of 490 students enrolled themselves in these courses. Curriculum Enrichment being an important aspect of academic exercise, the institution ensures that it contributes to the enrichment of curriculum. It may be mentioned here that the though the affiliating university, ie, Assam University Silchar designs the curriculum, a good number of faculties, of different departments, are part of the syllabus/curriculum preparation in the sense that they are members of BUGS, of their respective departments. Moreover the curriculum thus designed takes into cognizance issues relating to Environment and Sustainability and the fact that an Ability Enhancement Course (AECC) on Environmental Studies is taught to all students of both Arts and Commerce stream, as a compulsory

subject is a proof of the fact stated. Apart from AECC, the curriculum includes a SEC (Skill Enhancement Course) and in the syllabi of some of the departments the issues of professional ethics and gender studies are also included. Moreover, under the FYUGP (under NEP-2020), the institution has opted for NSS as a VAC and the NSS Unit of the College has more than 100 volunteers engaged in various activities. To ensure effective curricular delivery to the stakeholders the institution follows a robust feedback system. Feedback from all the stakeholders is collected analysed and action taken on the feedback is hosted on the institutional website.

Teaching-learning and Evaluation

The institution strategizes the teaching-learning process and student-centric methods are adopted so that the learning experiences of the students are enhanced. Apart from clearly spelling out the C.O's, P.O's and P.S.O's, debates, discussion, publication of wall magazines and seminars on topics related to the syllabi are conducted. To facilitate such programmes infrastructural requirements are made available to the students. To focus on student centric methods the Self-financing Cell of the college is currently offering seven (07) courses which are majorly application-based, experiential as well as participatory in nature. The college has also signed MOUs, with various institutions/organisations, which enhance their experiential learning.

The institution also ensures that ICT-enabled tools are used in the teaching-learning process so that the students can access the resources with just a click. Some of the tools used are WhatsApp groups for each class and subject, Google Meet or Zoom to conduct live online classes, creation of YouTube videos on the topics of the syllabi so that students can watch them multiple times to clear their doubts and development of e-learning portal in the website of the College, where study materials from all the academic departments are posted and which are remotely accessible. The Academic Monitoring Cell of the college, under the aegis of IQAC, has also introduced a "Mentor-Monitor Programme" under which faculty members from all academic Departments are assigned mentees and the counsel the students regularly.

Apart from these, the institution maintains a robust and transparent mechanism for assessing the learning outcomes of the students. The Continuous Internal Evaluation (CIE) process is carried out by conducting Unit Tests and Home and this was done even during the COVID-19 pandemic, wherein the Exam Cell took the initiative of conducting internal examinations in Online Format. The institution also takes care that the students are assessed periodically and in both online and offline modes, so as to maintain transparency and robustness. The institution also deals with internal examination-related grievances in a transparent, time-bound, and efficient manner.

The impact of the implementation of teaching-learning and evaluation is assessed through SSS which is analysed by the IQAC and time-bound action is taken accordingly.

Research, Innovations and Extension

Sans research, which is an integral part of academics, an institution falls short of the expected outcomes. Radhamadhab College aspires to be a premium institution of the valley in terms of its ability to cater to the educational needs of the students. To meet this aspiration innovative initiatives like online mode of conducting Internal Assessment, Creating Google Classrooms and YouTube Videos for imparting knowledge to students, E-Learning Portal for Students, Self-Financing Courses for enhancing the skill-set of the students, Community Engagement through NSS, Use of Smart and Virtual Classrooms by teachers and Training on Handloom Weaving are some of the innovative practices adopted by the institution.

The impact of the implementation of teaching-learning and evaluation is assessed through SSS which is analysed by the IQAC and time-bound action is taken accordingly. Accordingly, in the year 2023, 03(Three) numbers of Workshops were conducted on Intellectual Property Rights, Cyber Security and GST, and Use of ICT Tools in Academics. It needs to be mentioned here that the faculty of the college is engaged in research activities in the sense that out of a total number of 21 permanent faculties including Librarian (posts filled up) 17 faculty members have Ph.D as their highest degrees and a few of them are pursuing their Ph.D degrees. Moreover, more than 30 research papers have been published by the faculty members in reputed peer reviewed and UGC Care Listed Journals and a significant number of books/chapters in edited books have been published by the faculty members.

The college maintains its social cohesiveness through extension activities in the neighbourhood community to sensitize students and community members about different social issues. The college constantly promotes the participation of students and faculty members in various extension activities conducted majorly by the NSS Unit, Library and Students' Health Care Centre of the College. It is worth mentioning that for extension activities the College has received 08 recognitions from different Govt. and Non-Govt. organisations. The College presently has 09 functional MoUs with different organizations and institutions through which students/faculty exchange and academic collaborations are undertaken.

Infrastructure and Learning Resources

For creation of a congenial environment for teaching-learning process, the institution is constantly augmenting the physical facilities in terms of classrooms, laboratory and other ICT facilities. Presently the physical infrastructure of the College includes 17 classrooms, 01 Computer Lab with Language Lab facility, 02 smart & 01 virtual classroom, 01 conference hall, 01 Library browsing centre, 01 auditorium, 01 conference hall, separate common rooms for boys & girls, Rain water harvesting facility, adequate drinking water facility, Central Library with reading room, IQAC room, Teachers' Common room, Co-operative Society, Health Care Centre, Exam Cell, Exam Zone, Canteen, Gymnasium, Garden, Parking Zone, CCTV, Electric Transformer, High power Generator, Guest Room, Alumni Office and also Wi-fi enabled campus. During the last five years the expenditure incurred for infrastructure augmentation excluding salary is around 228.48 Lakhs.

The college library is automated with ILMS Software SOUL 3.0. having 19688 books and 30 periodicals. The library provides various modern facilities like Barcode-enabled computerized Smart Library Card, Internet, Reprography, Inter-library Loan, Online Searching, E-Resources, Consortium based Services, etc. The library has implemented smart attendance system and a smart display monitor for all the users of the library. The WEBOPAC facility enables the users to search books outside the library. The library has created a repository (Digital Library) with digitized collection of question papers, college magazine, prospectus, e-books, etc. The library publishes its annual newsletter-'*Informania*'. The library provides a wide range of e-resources under NLIST and British Council memberships.

The IT facilities of the college are regularly updated. The college has two types of internet connections, BSNL Sulabh broadband under NME project and 3 Bharat fiber optical connections. The Central Library has built a LAN around UTP CAT5 Cable with routing switches and has an Internet bandwidth of 1Gbps. Moreover, the College office is automated with offline server and Local Area Network with automated finance and accounts, administration and admission modules. Apart from on-line admission portal, the college has a dynamic website which is user-friendly and interactive for students' use. Apart from 107 P.C's for academic and administrative works, the teaching and Non-teaching staffs are provided with individual laptops for their convenient use.

Student Support and Progression

The college is committed towards providing a favourable environment for the welfare of the students and created various avenues for their upliftment. The college is considerate towards the students who are economically backward and provides all sorts of support to them. During the last 5 years, 88% students of the college have been provided with freeships and scholarships as per the directives of the state government. The college took up various capacity development and skill enhancement initiatives for the holistic development of the students like Yoga, Personality Development, Library Science, Sanskrit, Soft Skills, Self-Defence Course, workshops on Theatre, Weaving, Tailoring and Dress Making, Social Media Marketing, etc. Courses on ICT have also been introduced by the college like DCA, Office management, Tally, Cyber Security, etc. to enhance the computing skills of the students. The Career Guidance Cell organized a few counseling sessions for the students from which 42 students as per available data have been placed in various organizations during last 5 years. The college maintains a transparent mechanism (both online and offline) for redressal of students' grievances. The Grievance Redressal Cell, Internal Complaints Cell and Anti-Ragging Cell of the college have formulated policies and mechanisms to look into the interests of the students. During the last 5 years, only five grievances have been received which were duly redressed and actions taken accordingly. The data as (available with evidence) shows that 470 students have been placed and progressed to higher education during last 5 years. The students of the institution participated in 31 State, University, Inter College and Intra College events during last 5 years and also received awards and certificates. There is a registered Alumni Association of the college which works actively for the development of the college. In last 5 years they have organized a series of programmes in the campus and contributed financially for different activities related to students. The Gymnasium, Canteen and Terrace Garden of the college are maintained by the Amumni.

Governance, Leadership and Management

Influenced and inspired by the institutional motto-"Vis?vaji?vana?mr?itam Jn?a?nam"; the quality policies and plans, reflective of decentralization and participative management, are framed by the Principal in consultation with the G.B and the IQAC of the college . This decentralized tendency of the functioning of the college inculcates the idea of participation of students, teachers, parents, alumni, community, and other stakeholders. The services of the employees are regulated by 'Provincialisation of College Employees Act, 2005' and College Service Conduct Rules. The promotion and career advancement of the in-service teachers and librarian are made as Career Advancement Scheme (CAS).

E-Governance is carried out in Administration, Finance and Accounts & Student Admission. For evaluating teachers' performance and academic accountability the PBAS format is followed. The promotion of non-teaching staff is done as per guideline and circular issued by the Director, Higher Education, Government of Assam on the basis of State Government Employees' Service Rule. It is to be noted that in the last five years 42 FDP/training programmes were attended by the members of teaching and non-teaching fraternity in the last 5 years

The institution has effective welfare measures like pension, gratuity, provident fund etc. for teaching and non-teaching staff as per the directive of the Govt. of Assam. In addition to these, the college has many welfare schemes for teaching and non-teaching staff.

The institution develops different types of strategies for mobilization of funds to meet its aims and objectives. The government grants are mobilized by submitting proposals to the relevant authorities such as the UGC, the State Government, RUSA, MP LAD, like ICSSR, MAKAIAS, public sector organisations and other bodies etc.

for the augmentation of institutional infrastructure, academic improvisations and other necessary aspects. Funds are also mobilised through fees received from and receipt from Self-Financing Courses.

Some of the significant contributions of IQAC for institutionalizing the quality assurance strategies and processes include reviewing the teaching-learning process, preparation of academic calendar, implementation of mentor-mentee programme, online feedback system, academic and administrative audit, green, environmental and energy audit etc. Under the supervision of IQAC the different cells and sub-committees conduct different programmes throughout the academic session.

Institutional Values and Best Practices

The Institution has conducted Gender Audit and adopted various measures for the promotion of gender equity. A Committee for Prevention of Sexual Harassment at Workplace as per Vishaka Commission's Guidelines has been formed and renamed as Internal Complaint Cell (ICC) in subsequent time for the safety of the girls students of the college. Gender Sensitization Programmes are regularly organized by different cells/subcommittees. Courses on Gender Equity, Gender Sensitization are incorported in the curriculum of the UG Programmes. The institution provides various facilities for women on campus like 24X7 CCTV Surveillance System and Security Guards, Separate Girls' Common Room, Separate Toilet facilities for Girls, Counselling Programmes on female related issues, Courses on Taekwando, Yoga, Beautician, Tailoring and Weaving (Handloom), etc.

The college has installed Solar Power Panels in the campus as an alternate source of energy and has initiated a Rain Water Harvesting Project to conserve water. Other steps like making the campus plastic free, management of degradable and non-degradable wastes, plantation drives (on and off campus), Dibyangan facilities, etc have also been undertaken. Quality audits like Green, Energy and Environment have also been undertaken for improving the institutional environment. The various Cells under IQAC, academic departments and Students' Union work in tandem to organize different types of activities in the campus in order to provide an inclusive environment. World Human Rights Day, National Voters Day, Martyrs' Day, Bharatiya Bhasa Diwas and may more are organized every year by the students. The academic departments publish their Wall Magazine and also the annual College Magazine "Patraput" is published with students' creative writings. The students are involved in major decisions of the college through their representation in RUSA, IQAC, SVEEP Cell, Electoral Literacy Club, etc. The institute undertakes community based programmes in the adopted village. The NSS Cell organizes cleanliness drive, Swachata Abhiyan, plantation programme, etc. The college has adopted two Best Practices with the intention to promote students' upliftment and encourage them to excel further. They are:

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	Radhamadhab College, Silchar is affiliated to Assam
	University and follows the curriculum designed by
	the affiliating University. Assam University, Silchar
	has introduced the National Education Policy (NEP

2020) from the current acdemic year in colleges known as Four Year Under Graduate Programme (FYUGP) which has been duly implemented by the college. The course and curriculum of NEP 2020 as designed by the affiliating University in line with the UGC and Ministry of Human Resource Development has been exhaustively followed by the college. The college has already adopted certain measures in the process of implementing NEP 2020 like introduction of Interdisciplinary Courses weich can be opted by students from a variety of subject baskets along with their Discipline Specific subjects. A number of such Interdisciplnary subjects have been selected by the institution for the benefit of the students such as Library and Information Science, Philosophy, Education, Political science, etc. Also Value Added Courses like Yoga, NCC, NSS have been introduced by the college as a part of the NEP Structure.

2. Academic bank of credits (ABC):

Being an affiliated college under Assam University, Silchar, the college has followed the guidelines of the university and initiated the process of registration in Academic Bank of Credit. Accordingly the college has directed each and every student to create an account in the Academic Bank of Credit (ABC) and map their accounts for National Academic Depository (NAD) to E Samarth Portal of the university and submit the details of the same to the college. This has been done for the students of all the semesters. The college is ready to take the subsequent necessary steps as and when directed by the university.

3. Skill development:

The existing curriculum under Choice Based Credit System (CBCS) and also Four Year Under Graduate Programme (FYUG) under NEP 2020 designed by Assam University, Silchar enables the student to enhance their skill in their respective subjects through the Skill Enhancement Course (SEC) which is mandatorily pursued by every student. A number of subjects are offered by the college which can be selected by the students as Skill Development Course (SEC) under NEP 2020. The college also runs a number of Self-Financing Certificate and Diploma Courses which are intended for skill development and professional development of the students. Courses like Diploma in Computer Applications (DCA), Tally, Library & Information Science, Certificate Course in Weaving and Handloom, Tailoring and

Dress Making, Beautician, etc. are offered for the benefit of the students to enhance their skill and ability.

4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):

The Institution caters to the diversity prevalent in the valley by admitting students of different socio-ethnic and economic backgrounds and ensures exposure to the traditional knowledge system of our society. The Syllabi designed by the affiliating university, which has provision for different Indian languages, is followed by the institution. The FYUG Syllabus of Assam University, Silchar framed as per NEP has provision for Modern Indian Languages, such as, Bengali, Assamese, Manipuri, etc. which provide a purview to the cultural diversity of the valley. In relation to that, the Departments of Bengali and Manipuri of the institution teach the students the literature, language and culture of these communities. Moreover, the Self Financing Cell of the Institution conducts a Certificate Course in Sanskrit, which exposes the students to the core values of Indian society and familiarizes them with the linguistic and cultural enchantress of Indian society. The FYUG Syllabus of Philosophy, followed by the Department of Philosophy, also has reference to the nine recognised schools of Indian Philosophy (Vedic as well as NonVedic), which engage the students in epistemological discussions, thereby imparting a broad knowledge-base to Indian philosophical traditions and culture. Moreover, the Syllabus of the Department of English incorporates papers on Indian Writing in English and Indian Classical Literature in Translation, which exposes the students to the Indian culture, tradition and ethos. Apart from these, the other disciplines of study also comprise of courses and papers which integrate Indian Knowledge Systems in their programs.

5. Focus on Outcome based education (OBE):

Radhamadhab College, Silchar affiliated to Assam University facilitates pursuing of UG courses in various subjects under the scope of Outcome Based Education (OBE). All the courses offered by the college including the Self-financing courses also comes under the prospects of Outcome Based Education (OBE). All the academic departments are instructed to prepare the Programme Outcome, Programme Specific Outcome and Course Outcome and submit it to the authority who verifies and approves the same and then uploads the same in the

college website. The outcomes of the different courses are made known to the students by the teachers at the beginning of each session. It is also ensured that the teacher teaches the courses in the class in such a way that it is in conformity with the Programme Outcome, Programme Specific Outcome and Course Outcome.

6. Distance education/online education:

Radhamadhab College was the study centre of Indira Gandhi National Open University (IGNOU) under convergence scheme for quite a few number of years. Subsequently, the convergence scheme was withdrawn, thereby the college ceased to be a study centre of IGNOU. However, efforts are on to reestablish study centre of IGNOU. The college has already got the permission for opening a Study Centre of Krishna Kanta Handique State Open University (KKHSOU) in the college and admissions in Master Degree Programmes, Bachelor Degree Programmes and Diploma Courses for the current session have already started. The opening of the KKHSOU Study Centre added a new feather to the college in the sense that Post Graduate Students (M.A.) courses are now being taught by the faculties of the college. It needs to be mentioned that the closure of the institutions across the nation during COVID-19 pandemic has led to rethinking in teaching-learning methodology and has opened up new avenues in the form of Digital and Online Teaching-Learning process. Answering the need of the hour, all the departments of the college has adopted online modes of teaching in the form of Google Meet, Zoom and others. WhatsApp groups were formed by the departments and study materials were provided to the students in these groups.

Institutional Initiatives for Electoral Literacy

1. Whether Electoral Literacy Club (ELC) has been set up in the College?

Yes, Electoral Literacy Club (ELC) has been set up in college since 2019. The main objective of setting up ELC in the college is to create awareness among the students specially the new voters aged between 18-21 years about their voting rights and to explain them about the democratic system of our country and the various aspects of electoral process followed. It works on the principles of 'Every Vote Counts' and

'No Voter to be Left Behind' as envisaged by the election Commission of india. The Club organizes various types of awareness programmes and takes apart in Government initiatives to sensitize the students to exercise their voting rights.

2. Whether students' co-ordinator and co-ordinating faculty members are appointed by the College and whether the ELCs are functional? Whether the ELCs are representative in character?

Yes, the ELC of the college is functional with a Coordinating Faculty member. The constituttion of the Club for the current session is as follows: 1. Dr Bidhan Barman-Faculty Incharge of ELC 2. 3. What innovative programmes and initiatives undertaken by the ELCs? Participating in Rally on electoral literacy awareness organised by the District Administration, Govt. of Assam. 4.Door to Door Awareness/Campaign on Voting Rights in the community. 5. Uploading the advertisement of "Desh ka Form" in the college website and creating publicity for downloading the Voter Helpline App. 6. Assisting and cooperating with the District Election Administration through appointments of Assembly Level Master Trainers and National Level Master Trainer by the faculties of the college. 7. Demonstration of EVM and VVPAT in the college in presence of students, staff and residents of the community. 8. Participating in the Training Programme on SVEEP (Systematic Voters' Education and Electoral Participation) organized by District Administration along with NSS members of the college. 9. Assisting and cooperating with the District Election Administration in conduct of Assembly Polls and Parliamentary Elections through engagement of the college as Polling Station and executing other responsibilities like Presiding Officers and Polling Officers by the teaching and nonteaching staff of the college. 10. Organizing Awareness Campaign on "Mera Pehla Vote Desh Ke Live" for the students of the college. 11. Organizing Skit in the college campus promoting voter education and value of vote. 12. Appointment of one faculty of the college Dr Arunabha Bhattacharjee, Asstt Prof.

The college has taken certain initiatives in electoral related issues to spread awareness in the college, neighbourhood and also in the adopted village of the college. Activities are undertaken so as to highlight the importance of their vote and to ensure that they caste their vote meaningfully and rationally. Door to door campaigns are organised to spread awareness among the masses about their voting rights. Awareness programmes on "Mera Pehla Vote Desh Ke Liye" are organised for the students of the college aged about 18 years. Steps are also taken by the college to assist these students in incorporating their names in the Voter List. The college also initiates to demonstrate EVM and VVPAT for the benefit of the residents of the community. Participation in electoral processes is ensured by engaging in various duties as assigned by the district administration from time to time.

5. Extent of students above 18 years who are yet to be enrolled as voters in the electoral roll and efforts by ELCs as well as efforts by the College to institutionalize mechanisms to register eligible students as voters.

The students of the college who are 18 years of age are sensitized in different ways to enroll themselves in the electoral roll. Besides that, effective mechanisms are also designed by the college to register all the students of the college in the Voter List. National Voter's Day and awareness programmes on "Mera Pehla Vote Desh Ke Liye" are organised for the students of the college aged about 18 years. The college also participated in Training Programme on SVEEP (Systematic Voters' Education and Electoral Participation) organized by District Administration. for this purpose Besides these, the college also conducts talks, debates and essay competitions for the students to familiarise them with the process of election and voting.

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

The institution holds that curriculum is the formal mechanism through which intended educational means are achieved. Radhamadhab College implements the curriculum designed by Assam University, Silchar. The college offers Bachelor of Arts and Bachelor of Commerce Programmes, for both Pass and Honours Courses. The College has a clear, sequenced plan for curriculum delivery that ensures consistent teaching, learning and assessment procedures which have a clear reference for monitoring learning. To facilitate the implementation process, the following measures are taken:

- **1. Faculty Meetings:** The Principal organizes faculty meetings at the commencement of every semester in an arranged manner, in which there is a detailed discussion of execution of teaching-learning activities.
- **2. Departmental Meetings:** Heads of the Academic Departments organize Faculty Meetings at the Departmental level for the distribution of workload and its effective implementation.
- **3. Time-Table:** The Time-Table reflects the entire education program of the college. It provides the framework within which the work of the college proceeds. It is the tool through which the purpose of the college is to function. Time-Table ensures smooth and orderly working of curriculum activities. The Time-Table enables both learners and teachers to pay attention on one thing at a time. Time-Table consists of Academic Calendar as well as Central and Departmental Class Routine.

The Academic Calendar is prepared and showcased by the IQAC, upon consultation with all stakeholders and gets approved by the Principal for its effective implementation. Moreover, adhering to the Academic Calendar, the process of Continuous Internal Examination (CIE) is carried out. Internal Assessment is done through Unit Tests, Home Assignments, etc. During the Covid-19 pandemic, the institution even took up the initiative to conduct Unit test exams through online mode. In this connection, students were given the opportunity to submit Home Assignments through designated email ids created by each academic department. Subsequently, upon reopening of the educational institutions, the Exam Cell of the college also conducted the internal assessment examination in Google Form Format to acquaint the students with digital facilities in academics.

On the basis of different modes of assessment, internal marks are assigned to the students. The assessment results reflect the students' strengths and weaknesses. Students are given Home Assignments on various topics from the syllabi to assess their subject knowledge and competency. Home Assignments are conducted to gauge their language, reading and writing skills. Students' Seminars are also arranged by many Departments to judge their verbal abilities. Internal Assessment is set according to Course Outcomes and Programme Outcomes.

Response:

The curriculum designed by the affiliating university, AUS, recognizes the relevance of the issues pertaining to Environment and Sustainability, and in this connection, an Ability Enhancement Compulsory Course (AECC) on Environmental Studies is taught to all the students of both Arts and Commerce stream. As it is a compulsory course, all the students are mandated to study this course, so as to familiarize them with the issues related to environmental problems and various sustainability measures to overcome those problems. This course is incorporated at the undergraduate level to make students well aware of environmental concerns and thus evaluate environmental issues and make sound decisions. Apart from AECC, the curriculum includes an SEC (Skill Enhancement Course) on Applied Ethics, under the syllabus of Philosophy pass and honors course, in which the issues of Human Value, Professional Ethics, and Gender-related issues are taught. Moreover, the syllabi of TDC Commerce and TDC B.A, English, B.A Education and other programs also has papers that involve the topics of Professional Ethics and Gender Studies. Moreover, in the syllabi of almost all courses, such as English and Bengali Literature, History, Commerce, etc. crosscutting issues related to gender, human values, ethics, etc. are included. The institution also organizes Workshops/Seminars from time to time to create awareness among the students and sensitize them regarding environmental issues, gender issues, and human values.

The NSS Unit of Radhamadhab conducts various extension activities which aim at promoting a sense of responsibility towards the environment for ensuring sustainability as well as inculcating in students ethical and social values. These activities help in actualizing the theoretical framework of the curriculum into practice. Some of the activities conducted by the NSS Unit of this college which are relevant to this cross-cutting issues are:

2.3 Teaching- Learning Process

2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The institution takes care that in the teaching-learning process, student-centric methods are adopted so that the learning experiences of the students are enhanced. In this regard, it is taken care that the students engage in debates and discussions among themselves with respect to different topics selected from the prescribed syllabi. It is also ensured that thought experiments are employed in the classroom, as a method to kindle their quest for experiential learning. Various discussion groups are created within the classroom by teachers, and these groups participate in internal discussions for a better understanding of the subject. Moreover, the college has its own Computer Lab, in which the students, especially from the Commerce Department, engage in various activities that contribute to enhancing their problem-solving abilities. Furthermore, the Self-Financing Cell of the college offers certificate courses in Computer Application, Office Management, and Tally. It also provides a Diploma Course in Library and Information Science. All these courses are majorly application-based and are experiential as well as participatory in nature. The college has also signed MOUs with NIELIT and ICT Academy through which students get exposure to the IT industry via various training programs, which enhance their experiential learning.

The institution ensures that ICT-enabled tools are used in the teaching-learning process so that the students can be provided with the facility of self-paced learning; the learning materials are available with them at all times, which they can access with just a click and restrictions on physically attending classes do not affect the continuity of their study. The first tool used by the teachers, in this regard, is the creation of WhatsApp groups for each class and subject. These groups serve as the medium of communication between the teachers and students. They also provide a platform to share e-materials for learning, in the form of PDF & Word documents of various topic-related notes. Moreover, many departments also use such meeting platforms as Google Meet or Zoom to conduct live online classes where there is direct interaction with the students. Some faculty members have also created YouTube videos on the topics of the syllabus that are shared with the students, who can watch them multiple times to clear their doubts.

The college also has two Smart Classrooms and one Virtual Classroom where regular classes are taken and presentations/videos/films are shown so as to facilitate audio-visual engagements of the students. The college website has an E-Learning Portal where study materials from all the academic departments are posted which can be accessed by the students remotely at all times.

The Academic Monitoring Cell of the college, under the aegis of IQAC, has also introduced a "Mentor-Monitor Programme" under which faculty members from all academic Departments were assigned mentees. The faculty members, as Mentors, take responsibility for the mentees and help them through regular counseling sessions.

Apart from these, all the Departments publish Wall Magazines every year where the write-ups on specified themes are contributed by the students.

2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The institution maintains a robust and transparent mechanism for assessing the learning outcomes of the students. The Continuous Internal Evaluation (CIE) process is carried out by conducting Unit Tests and Home Assignments to assess the learning levels of the students and to identify their strengths and weaknesses. Even during the COVID-19 pandemic, the Exam Cell of the institution took the initiative of conducting internal examinations in Online Format. This initiative of online conduct of internal assessment made the process of evaluation transparent and accessible for the students in the context of the closure of the institution due to the pandemic. Moreover, it helped the faculty members understand the learning progress of the students and take measures to modify the teaching-learning mechanism accordingly. It was also observed that some students were unable to take the internal exam in Online Format, due to unavailability of the internet and/or smartphones. So, the Exam Cell took the initiative of identifying those students and they were given the opportunity of submitting the Home Assignments in offline mode in the concerned academic departments. The institution takes care that the students are assessed periodically and in both online and offline modes, so as to maintain transparency and robustness. The external assessment is conducted by the affiliating university in the form of end-semester examination.

The institution deals with internal examination-related grievances in a transparent, time-bound, and efficient manner. The Exam Cell of the institution ensures that all the students are provided with proper facilities for giving internal exams and in this connection, the institution has provision for both online and offline modes of conducting internal assessment examinations. It is worth mentioning that in light of the prevalent COVID-19 pandemic, the institution made provision for online conduct of internal examination through Google Form Format. Although almost all the students successfully appeared in the exam, some students were unable to take the exam in Google Form Format due to lack of internet facility and/or smartphone unavailability. These students expressed their grievances to the Exam Cell of the

institution, and immediate measures were taken to address their grievances. In this connection, the Exam Cell made provision for Home Assignments for the grieved students in order to make sure that their learning progress is adequately assessed. Even in the offline mode of examination, the Exam Cell facilitates the students with the opportunity to re-appear in exams if there are any grievances. So, the mechanism to deal with internal examination-related grievances of this institution is very transparent, time-bound, and efficient.

The external assessment of the students is done as per the examination schedule prepared by the affiliating university, i.e., Assam University, Silchar. The faculty members of the institution are appointed by the affiliating university for question paper setting, invigilation duty, and paper evaluation. The institution is also a designated Degree Examination Zone via which answer scripts of students, registered under Assam University Degree Programme, are evaluated. Grievances related to external assessment (end-semester examination) are handled by the affiliating university through the process of reevaluation.

The Institution follows the Curriculum designed by the affiliating university, i.e., Assam University, Silchar (AUS). The Courses that are taught under the B. A and B.Com Programmes are prepared by the Board of Under-Graduate Studies (BUGS), AUS. In accordance with the syllabi, the IQAC of the institution takes the initiative to prepare the Programme Outcomes (POs) for all Programmes. The responsibility of preparing the Programme Specific Outcomes (PSOs) and Course Outcomes (COs) is entrusted to the Heads of all academic departments. The institution has a detailed display of the Programme Outcomes, Programme Specific Outcomes, and Course Outcomes of the different programmes and courses offered by the institution on the official website of the college. All the academic departments of the college prepare their respective Programme Specific Outcomes and Course Outcomes, under the supervision of the Head of the Departments, which are then discussed in Departmental Meetings, and a plan is chalked out to ensure that the programme outcomes and course outcomes are achieved. Subsequently, at the beginning of the Semester, the H.O.D. and other faculty members discuss the outcomes of studying the concerned programme/course with the students and acquaint them with the prospects and job opportunities that can be availed.

The broad POs of studying Bachelor of Arts Programme, as identified by IQAC, are as follows:

Response:

The institution follows certain mechanisms to evaluate the Programme Outcomes and Course Outcomes. The institution ensures that the students are well acquainted with the outcomes of studying the concerned programs/courses. The Heads of all the academic departments arrange an induction class at the beginning of each semester in which the students are acquainted with the outcomes of the courses and programs of

study. To ensure that the program and course outcomes are attained, the Exam Cell of the institution makes provision for Continuous Internal Evaluation (CIE) of the students, in the form of Unit Tests and Home Assignments. The process of continuous assessment of the students ensures that the teaching faculty has a bird's-eye-view of the academic progress of the students, and can gauge the level of prospective academic outcomes attainable at the end of the program. Each academic department keeps a personal record of the mechanism employed and the results thereof related to the course and program-specific outcomes.

The mechanism that is employed to evaluate the attainment of POs and COs are as follows:

- The performance of the students in the examination (internal and external) is regarded as the main gauge for determining the Course and Program Outcomes. The program's effectiveness is evaluated based on the grades obtained by the students in the relevant external exam (final exam).
- Students' specialized knowledge and skills are observed through internal examinations that the college conducts in accordance with the affiliated university's protocol. The students are evaluated in this manner based on the grades they received in the relevant college internal exams.
- In order to gauge the student's knowledge and comprehension abilities, certain topics are assigned as homework by each Department.
- Departments also organize departmental seminars, group discussions, exams, and debates to evaluate program and course outcomes.
- The institution relies on feedback from students, parents/guardians, alumni, and teachers to evaluate its teaching and learning system.
- With the purpose of assisting students in achieving program objectives and providing appropriate advice on a range of career alternatives, the college maintains a career counseling cell.
- Staff meetings are periodically convened at the department level to discuss student progress and make sure that the curriculum is completed on time, paving the path for the best possible learning results.
- Lastly, data related to progression to higher education and placement of pass-out students (a comprehensive list of which is attached in Criterion 5) are collected to evaluate whether the POs and COs are attained.

3.2 Innovation Ecosystem

Response:

The college aspires to be a premium institution of the valley in terms of its ability to cater to the educational needs of the students. To meet this aspiration, different innovative initiatives have been adopted for the creation and transfer of knowledge. These are:

- 1. Online mode of conducting Internal Assessment: With the objective of familiarizing the students with ICT facilities in academics, the Exam Cell of the college had initiative the process of conducting unit tests, as part of internal assessment, in Google Form Format. Moreover, in some instances, the students were also asked to submit their Home Assignments in departmental email ids, so that they are acquainted with all forms of digital facilities.
- 2. Creating Google Classrooms and YouTube Videos for imparting knowledge to students: Some of the faculty members of the college have taken the initiative to create Google Classrooms for the students so that they learn the act of online interaction and virtual

- participation in education. Along with that, some faculty members have also created YouTube videos for the students, which they can access even remotely at all times. Moreover, in the college website, the links to join Whatsapp groups are also shared through which they can easily access all study materials.
- 3.**E-Learning Portal for Students:** The college also has a provision for E-learning Portal in the college website in which study materials of all subjects are posted. This ensures academic flexibility and beyond-the-schedule availability of learning opportunities.
- 4. Self-Financing Courses for enhancing the skill-set of the students: There is a Self-Financing Cell of the college which offers various innovative courses, such as, Certificate Courses in Cyber Security and Social Media Marketing, Diploma in Computer Application, Diploma in Library and Information Science, etc. These Courses provide an opportunity for the students to enhance their skill-set and prepare themselves for job-opportunities in the real world.
- 5. Community Engagement through NSS: The NSS Unit of Radhamadhab College has over 100 volunteers who actively engage in community-service and participate in programs, which are aimed at ensuring their holistic development. Some of the prominent programs conducted by the NSS Unit of Radhamadhab College are Awareness Program on Tobacco Consumption, Swaach Bharat Abhiyan, Van Mahotsav, Electoral Literacy Awareness, Blood Donation, Plantation Drive among others. These initiatives ensure that students are aware of and get education on issues of environmental sustainability, community upliftment, health preservation and the like.
- 6. Use of Smart and Virtual Classrooms by teachers: The IQAC of the college has taken the initiative to transform two classrooms into Smart Classes and one into Virtual Class which are regularly used by the faculty members to take classes. This initiative helps both the teachers and the students in coping with the technological advancements in education.
- 7. **Training on Handloom Weaving**: The Women Cell of the college arranged a one-month training program on Handloom for the female students and this initiative attained its fructification when the students were able to weave Asomiya Gamosas by their own upon completion of the training.

Response:

For creating a congenial environment in teaching-learning process, the institution is putting a lot of effort to augment the physical facilities in terms of classroom, laboratory, Yoga, Gymnasium and ICT enabled facilities. The following are the infrastructural facilities available in the college:

- 1. There are 17 classrooms (3 Assam Type from college resources, 5 RCC funded by UGC grant, 2 RCC from state Govt. grant, 6 RCC funded by RUSA grant and 1 funded by MP untied fund).
- 2. There is a Computer Lab along with Language Lab facility installed in it having around 30 computers.
- 3. Out of them 02 classes have been converted into Smart Class and 01 class have been turned into Virtual Class.
- 4. There is one Conference Hall and one Browsing Centre (Library Digital Section) with internet and Wifi facility.
- 5. The college also has an Auditorium in the first floor of the college and one Conference Hall equipped with ICT facilities for organising cultural and other activities.
- 6. There are separate Common Rooms for Boys and Girls with sufficient toilet facilities.
- 7. The college has made arrangement for Rain Water Harvesting along with adequate drinking water facility.
- 8. The library of the college placed on the first floor has separate Reading Rooms for students and teachers along with Digital Section, Stack section, Periodical Section. etc. It is automated with modern facilities like Bar Coding, Digital Attendance, Smart Display, Digital Library, etc.
- 9. The college has a separate space for IQAC, Teachers' Common Room, Cooperative Society, Health Care Centre, Exam Cell, Exam Zone, etc.
- 10. The college has a canteen with different types of refreshments and food items available for the

students, teachers and staff of the college.

- 11. The college has a Gymnasium Room with standard equipments such as weight lifting set, dumbbells, chest expander etc. for the benefit of the students.
- 12. The Women's Hostel funded by UGC is under construction and shall be completed soon.
- 13. The college has no playground itself but has a small space for conducting outdoor games like badminton, cricket within the campus. The college has facilities for indoor games like table tennis, carom, chess etc. The Annual Sports events are conducted every year in College Week.
- 14. Yoga Awareness Programmes and Yoga Sessions are conducted in the Auditorium. Besides, Taewakando classes are also conducted for the female students of the college.
- 15. The college has gardens with lot of greenery and landscaping.
- 16. There is a Cultural and Co-Curricular Activities Cell in the college functioning under IQAC which conducts cultural events, Art Competition, Debate, etc with active students' participation.
- 17. Every academic department of the college has separate space for Wall Magazine created by the students.
- 18. Other facilities like staff & student Vehicles Parking Zone, drinking Water Cooler, CCTV cameras for security, Fire Extinguisher, High power Generator, Electric Transformer, Guest Room, Alumni Office, etc. are also maintained by the college to ensure a smooth atmosphere.

4.2 Library as a Learning Resource

4.2.1

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

Response:

The Bipin Chandra Memorial Library of the college uses the ILMS Software SOUL, version 3.0 provided by INFLIBNET Centre, Gujarat and is automated with Circulation, Cataloguing and OPAC facilities. The library provides various digital facilities like Barcode-enabled computerized Library Card, Online Circulation, Internet, Reprography, Inter-library Loan, Online Searching, E-Resources, Consortium based Services, etc. The library has the facility of Departmental Library for each department, having a separate collection on each subject.

The library has sections like Stack Area, Reading Room, Periodical Section, Reference Section, Special Local Collection (Repository Centre), Digital Section, etc. The total collection of the library stands with 19688 books. 1952 ready reference, 30 periodicals and 08 newspapers. The library functions with the support of the Library Committee which plays a major role in functioning of the library and major library decisions. Library Orientation Programme is conducted at the beginning of the session for new students along with different types of programmes, workshops, yoga sessions, career counselling sessions, invited talks, etc. from time to time. Also Library Literacy Programme is conducted by the library in lower primary schools of the community. The library confers the Best Library User Award annually among the students. The library publishes annual newsletter of the library christened as 'Informania' outlining informative articles on Library and Information Science, tools of the library, activities, services and digital facilities of the library, etc.

The library has adopted the following measures for providing digital facilities:

- 1. ILMS: The library uses the ILMS Soul 3.0 with totally automated Circulation, Cataloguing and OPAC facilities. The automation process started in 2011.
- 2. Bar Code Technology: The library has Bar Code enabled Smart Library Card for the students, teachers and staff of the college along with bar-code tags in library books.
- 3. Smart Attendance System: The library has implemented smart attendance system for all the users of the library including teachers, staff and students.
- 4. Smart Dispay: The library has installed a smart display monitor in the library displaying the library details, services and number of users visiting the library every day.
- 5. Online Searching and Browsing: The book collection of the library can be searched by the users using

the OPAC module (inside the library) and WEB OPAC module (outside the library) of SOUL ILMS.

- 6. Digital Library: The library has created a separate Digital Library with remote access facility using D-Space Digital Library Software and has created an institutional repository with digitized collection of question papers, college magazine, prospectus, e-books, etc.
- 7. Wi-Fi enabled library: The library is Wi-Fi enabled and Internet is available for all the users of the library.

Subscription to E-Resources:

The library is a member of NLIST Programme of INFLIBNET providing access to more than 6000 e-journals and 600000 e-books. The library has also taken membership of British Council and National Digital Library for access to a wide range of e-resources for the benefit of the students and teachers of the college.

Optimal Utilization of the library:

The library is utilized by the library users to a large extent. The teachers and students come to the library to satisfy their information needs for various purposes like classroom teaching, research, assignments, examination, etc. The details of the foot fall has been uploaded here.

Response:

The IT facilities of the college are regularly updated. The college has two type of internet connections, BSNL Sulabh broadband under NME project and 3 Bharat fiber optical connection of 100 mbps, 100 mbps & 200 mbps speeds respectively. The fiber optical connections are installed in the Central Library, Office, IQAC from where internet connections are made available in various places like Exam Cell, Exam Zone, Teachers' Common Room, Principal's Room, etc. Also the Library and the Academic Departments are networked through Wi-Fi with unlimited data connection with 03 Routers installed in Teachers' Common Room, Principal's Room and Library. The college has built two Smart Classes with digital interactive monitor and one Virtual Classroom with 360 degree rotatable camera and associated sound systems. The Conference Hall of the college is also equipped with ICT facilities. The Computer Lab has 35 desktop computers with internet connectivity. The Central Library has built a Local Area

Network (LAN) around UTP CAT5 Cable with routing switches and has an Internet bandwidth of 1Gbps. The library has 02 servers, 10 desktops and other accessories adequate to cater to the needs of users for accessing OPAC, Digital Library and E-resources. The library has also enabled Smart Attendance System with Bar Code Reader for all the users coming to the library along with Smart Display to highlight the activities and daily visits to the library. College office is automated with offline server and Local Area Network with automated finance and accounts, administration and admission modules. The college has also implemented online admission portal and a separate E-Learning portal for the students. The college has a dynamic website which is updated regularly and kept user-friendly and interactive for students' use. College has 107 computers for academic and administrative works, 11 printers, 4 scanners, 4 Reprographic machines and 2 projectors. The teaching and Non-teaching staff are provided with individual laptops for their convenient use. During lockdown period the college IT cell has upgraded its teaching-learning process & examination to online mode through creation of Whatsapp group, Google form etc. The college has also conducted workshops and programmes on how to apply ICT in academic affairs. The whole college is under CCTV surveillance with CC Cameras installed in all the classrooms and corridors of the college, office, library, etc.

6.1 Institutional Vision and Leadership

6.1.1

The institutional governance and leadership are in accordance with the vision and mission of the Institution and it is visible in various institutional practices such as NEP implementation, sustained institutional growth, decentralization, participation in the institutional governance and in their short term and long term Institutional Perspective Plan.

Response:

The vision and mission of the institution is very much reflected in its various administrative works and governance pattern. Deeply influenced and inspired by this institutional motto-"Visva Jiyanamritam Jananam" which reflects the vision and mission of the college, the quality policies and plans are framed by the Principal in consultation with the academic and administrative members of the college.

The Institution subscribes to the idea of decentralization and participative management as is reflected in its policy formation and implementation. The governance of the college is carried out by the Governing Body which consists of Principal as the Secretary and other representative members of Assam University, local administration, teaching and administrative sections, etc.thus framing the policies and plans of the institution in tune with its vision and mission. The IQAC of the college is instrumental in applying the principles of decentralization through the formation of various Cells/Sub-Committees like the Academic Monitoring Cell, Admission, Computer and IT Cell, Library Committee, Women's Cell, Committee for Games and Sport, Cultural cum Co-Curricular Activities and Grievance Redressal Cell, Career Guidance, Anti-Ragging and ST/SC Cell, Self-Financing Cell, Students' Heath Care Centre, NSS, etc which work in different fields for the overall development of the college and contribute to the aesthetic progress and welfare of the students. The academic deoartments, library and college office function on their own as independent but integrated organs of the college and the overall academic affairs are regulated and managed by the Vice-Principal appointed by the Principal and approved by the Governing Body of the College. This decentralized tendency of the functioning of the college inculcates the idea of participation of students, teachers, parents, alumni, community and other stakeholders. The college is in constant touch with the Alumni Association and the Students' Union for the greater interest of the college. The following governance strategies are carried out in tune with the vision and mission of the institution:

- Introduction of innovative academic programmes
- Planning for infrastructural developments
- Participation of the stakeholders in Governing Body, IQAC, Cells/Committees
- Undertake extension activities, community service involving students through NSS
- Meaningful co-curricular activities to generate a sense of discipline, ethical and moral values in the students
- Participatory governance and decentralization of administrative functions
- The Governing Body approves the institutional policies, systematic rules, financial transactions and action-plans of the college.

Regarding NEP implementation the college has introduced the FYUG Programme under NEP 2020 as

initiated by Assam University and has organized awareness programmes and workshops on NEP 2020 for stake holders of the college. The college has also formed a Task Force for NEP implementation as per DHE guidelines. Some of the teachers of the college are also members of NEP Implementation Committee of the affiliating university.

6.2.1

Response:

The functioning of the institutional bodies in terms of academic and administrative affairs are carried out in a systematic matter. The academic matters relating to course curriculum, teaching-learning, examination, internal assessment, filed work, projects, results, etc. are supervised by Assam University, Silchar. Regarding services of the employees, the college follows the regulations of 'Provincialisation of College Employees Act, 2005' and College Service Conduct Rules. The technical matters relating to appointment and other administrative affairs are controlled by the Director of Higher Education, Government of Assam. The faculty of the college are appointed as per the latest rules issued by the Director of Higher Education, Government of Assam in compliance with UGC guidelines. In addition to this, the promotion and career advancement of the in-service teachers and librarian are also made as per rules and guidelines of Career Advancement Scheme (CAS) guided by the same bodies. The recruitment of the non-teaching employees and their promotion and other service rules are framed by the Government of Assam.

The development plans and policies as framed by the Principal are guided and approved by the Governing Body. The different sections of the Principal's office like accounts, establishments, admission, etc is governed by the Administrative and Financial Rules of the Government of Assam. The academic matters are carried out by the Academic Departments of the College headed by the Head of the Departments in consultation with the Vice-Principal and IQAC of the college. The IQAC forms different Committees to help the Principal indifferent functional areas of academic and administrative affairs. There are twelve Cells/Sub-Committees under IQAC like the Academic Monitoring Cell, Admission, Computer and IT Cell, Library Committee, Women's Cell, Committee for Games and Sport, Cultural

cum Co-Curricular Activities and Grievance Redressal Cell, Career Guidance, Anti-Ragging and ST/SC Cell, Self-Financing Cell, Students' Heath Care Centre, NSS, etc which work in different fields for the overall development of the college and contribute to the deployment of institutional strategic and development plansThe Principal of the institution prepares a strategic plan in consultation with the IQAC, academic head of the departments, senior teachers and various cells/committees at the beginning of the year. This strategic plan includes various facets with respect to infrastructure, academic, administration and other aspects of the college to be implemented for the whole year. The activities to be conducted by various cells/committees are clearly spelled out and placed before the IQAC for approval. Other matters with regard to infrastructural development and other aspects relating to financial aspects are placed before the Governing Body for approval. The Principal in consultation with the senior administrative officer prepares the college budget incorporating the financial obligations for carrying out the activities as mentioned in the strategic plan and the said budget is placed before the Governing Body. The adopted plans and programmes are effectively deployed by different stakeholders throughout the year under the supervision and guidance of the IQAC.

Performance Appraisal System for Teaching and Non-Teaching Staff:

The performance appraisal of the teaching and non teaching staff is based on various parameters. For teachers the performance is evaluated on teachers' efficiency, conduct, attendance in class, students' feedback report, etc. and a Performance Appraisal Report is issued by the Head of the Institution which is required in CAS promotion of teachers. The college follows the guidelines of UGC and DHE, Assam for evaluating teachers' performance and academic accountability in the Performance Based Appraisal System (PBAS) format which is a self-apprised report of his/her academic performance (in API format). On Submission, the API of the teacher is verified by IQAC and recommended to the Principal for promotion who constitutes a Departmental Promotion Committee as per University's directive for final scrutiny and ultimately forwards it to DHE, Assam for accord of promotion. The promotion of nonteaching staff is done as per guideline and circular issued by the Director, Higher Education, Government of Assam on the basis of seniority as per Assam State Government Employees' Service Rule. Further, the annual performances of the employees are recorded in the service book of the employees every year. The teachers and employees who are granted Duty Leave for attending any training programme/Refresher Course/Orientation Programme intimate their completion of the programme to the Principal which is incorporated in their Service Books.

The institution has effective welfare measures like pension, gratuity, provident fund etc. for teaching and non-teaching staff as per the directive of the Govt. of Assam. In addition to these, the college has the following welfare schemes:

1. The college has Group Insurance Scheme (GIS) and Group Savings Linked Insurance Scheme (GSLI)

for the teaching and non-teaching staff.

- 2. The college has initiated the Radhamadhab College Employees' Thrift and Credit Cooperative Society to facilitate savings and loan requirements of the employees.
- 3. The college has initiated Medical Relief Fund for the benefit of the employees. Contribution to the MRF is made by the employees @ Rs 300/- per month and the same is utilised to meet the medical emergency of the employees and members of their families.
- 4. Departmental cubicles for each department are provided with adequate seating provisions, stationery, etc for teachers.
- 5. Both the teaching and non-teaching staff are provided with Laptops and Wi-Fi facility.
- 6. Casual Leave for 12 days and Earned Leave (10 days for teachers and 30 days for non-teaching staff) are granted to the employees.
- 7. Maternity Leave of 6 months and Child Care Leave for 2 years are granted to the female employees.
- 8. Employees, who have been appointed before February, 2005 are entitled to pension benefits after their superannuation as per Assam Government rules of OPS.
- 9. Warm felicitations are given to the members of Teaching and Non-Teaching staff on their academic achievements and superannuations. Teachers are felicitated by the Teachers' Council on achieving their Ph.D.
- 10. The college has canteen facility for light refreshments for the teaching, non-teaching and students of the college at a nominal rate.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

Mobilization and Utilization of Fund and Resources:

The institution develops different types of strategies for mobilization of funds to meet its aims and objectives. The government grants are mobilized by submitting proposals to the relevant authorities such as the UGC, the State Government, RUSA, MP LAD, etc. for the augmentation of institutional infrastructure, academic improvisations and other necessary aspects. Various types of Project Proposals are forwarded to different funding agencies like ICSSR, MAKAIAS, public sector organisations and other bodies for grant of funds. Funds are also mobilised through fees received from students under different heads like Admission Fee, Tuition Fee, Sports Fee, Library Fee, etc. Beside these, the institution runs few Self-Financing Courses for mobilization of fund which is taken care of by the Self Financing Cell of the college. The college also has a Study Centre of K.K.Handique State Open University (KKHSOU) which started functioning in mid 2023. The share money that will be received from the same will be utilized for the benefit of the students and augmnetation of infrastructural facilities of the college. The funds received are optimally utilized by the institution through different bodies like the Governing Body, IQAC, Purchase Committee, Construction Committee, Library Committee, etc which ensure execution of the plan and proper utilization of the fund received. The procurement and utilisation of these funds are also ensured through auditing at the completion of the financial year.

The grants received from various agencies are optimally utilized by the college. Expenditure incurred in connection with such grants are recorded meticulously and audited by the Chartered Accountant . The utilization certificate are subsequently sent to the appropriate authorities. The college utilizes its infrastructural resources for various purposes and provides space for Alumni Association, Health Care Centre, Employees' Thrift and Credit Cooperative Society, Canteen, Gymnasium Centre, Weaving and Handloom Centre, K.K. Handique State Open University Study Centre, etc. Besides these, the college campus is time to time used for Election purpose, different competitive Govt. exams and Covid Testing and Vaccination Centre in 2020, 2021.

Financial Audits:

The Internal Audit of the college is conducted by Registered Chartered Accountant who is engaged for college as per the decision of the Governing Body at the end of each financial year. All the financial records maintained by the college relating to Income and Expenditure Account, Receipts and Payments Account, Bank Reconciliation, Balance Sheet, Fund Transactions, Balance Sheet, Cash Book, Ledgers, Vouchers etc are thoroughly audited by the Registered Chartered Accountant. The Audit Report as issued by them is thoroughly studied, analysed and placed before the Governing Body for approval. In the process of auditing, if the Chartered Accountant points out any anomaly/objection with regard to the financial records, the same is met by the Account Section by producing necessary vouchers, documents,

etc. corresponding to the problem. The External Audit is conducted by the Government from time to time at a gap of five/six years. It needs to be mentioned here that the last Government Audit upto financial year 2016 was undertaken by the Audit Department of the Govt. of Assam which was duly passed.

6.5.1

Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes. It reviews teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals and records the incremental improvement in various activities

Response:

The following are some of the significant contributions of IQAC for institutionalizing the quality assurance strategies and processes in teaching-learning and various activities of the college:

- 1. The entire process of reviewing the teaching-learning process and learning outcomes is accomplished by IQAC through its different cells and committees.
- 2. The IQAC prepares the Academic Calendar to initiate the process of teaching learning. Also instructs the Academic Departments to prepare its individual departmental routine and incoprporate remedial classes in the class routine.
- 3. The IQAC ensures that the Mentor-Mentee programme is effectively implemented by every department.
- 4. The IQAC initiates the process of continuous internal evaluation in the form of Unit Tests, Home Assignments, Google Form, etc. and ensures that the learning outcomes of the students are assessed periodically and their progress is recorded for evaluating their learning progress.
- 5. All the academic departments are encouraged by IQAC to organize different departmental activities in order to involve the students for their cognitive and skill development like Guest Lectures, Seminars, Wall Magazines, Essay Competition, Group Discussion, etc.
- 6. The IQAC also collects the activity reports annually from each Department and Cells for quality assurance and record.
- 7. The IQAC with the help of the Students' Health Care Centre conducts regular health check-up of the students followed by Haemoglobin Test, Blood Grouping diagnosis test, etc. Also Health Camp in the community, Blood Donation Camp in the campus and Awareness Programmes on diseases are other important activities of the Cell.
- 8. The IQAC guides the Career Counselling Cell to conduct different types of Lectures, Motivational Sessions, etc. and addresses different career issues for the students.
- 9. The IQAC guides the NSS Cell to organize different types of programmes in the college,

- community and in adopted village with active students' participation.
- 10. The Grievance Redressal Cell has been formed by IQAC to address any grievance of teachers, staff or students.
- 11. Online Feedback System has been initiated by IQAC.
- 12. The IQAC organizes various types of Guest Lectures, Seminars, Awareness Programmes, Gender Sensitization Programme, Entrepreneurial Workshops, Faculty Development Programme, Training Programmes, Yoga Sessions, etc for the benefit of the students and teachers of the college.
- 13. The IQAC frames the Perspective Plan, Annual Gender Sensitization Action Plan and other important policies.
- 14. The IQAC looks after the career development/progression of the staff of the college.
- 15. The Sports and Cultural Cell of the college under the guidance of IQAC organizes Social Week and Sports Meet annually with active students' participation in different types of inter-college and university competitions.
- 16. The IQAC guides the Women's Cell to look after the welfare of the girl students and staff of the college; also conducts Self-Defence Course, Tailoring & Dress Designing and Handloom Weaving Courses for the benefit of the female students of the college.
- 17. The IQAC takes initiative to publish the Code of Conduct, College Research Journal and Newsletter.
- 18. The IQAC has been instrumental in conducting the Academic and Administrative Audit of the college and has also taken steps to conduct the Green, Environmental and Energy Audit as per guidelines prescribed by NAAC.
- 19. The IQAC has taken steps to sign MOUs for collaborations with different organizations.
- 20. The IQAC has been instrumental in installing the Solar Power Energy in the campus.
- 21. In order to make a quality check on the institution in the global scenario, ISO certification 9001:2015 was conducted and obtained by IQAC.

Response:

The college has initiated Gender Audit and has adopted certain measures for the promotion of gender equity during the last five years.

Gender Equity and Sensitization in curricular and co-curricular activities:

The college has been initiating a number of gender equity activities. All the cells and committees of the college maintain gender equity through their different activities i.e. Games and Sports, Cultural cum Extra-Curricular activities Cell, Grievance Redressal Cell, Career Guidance Cell, Anti Ragging and SC & ST Cell, etc. For the welfare of the girl students, there is a separate Cell called 'Women's Cell'. Various types of programmes are organized by Women's Cell for the benefit of the female students of the college keeping in tune with the Annual Gender Sensitization Plan chalked our every five years by IQAC to empower them and enhance their entrepreneurial skills. As gender sensitization action, the Women's Cell in collaboration with Rotary Club, Silchar provided a vending machine in the girls' common room specifically to maintain proper hygiene of the female students. International Women's Day is observed on 8th March every year in a befitting manner to promote gender equality. The Students' Health Care Centre also takes care of the female students by taking up health check-ups, blood group diagnosing, anemia testing, etc. and organizing awareness programmes on various health issues. A Committee for Prevention of Sexual Harassment at Workplace as per Vishaka Commission's Guidelines has been formed which has been renamed as Internal Complaint Cell (ICC) in subsequent time for the safety of the girls students of the college. There is enrollment of 54.06% (2023-24), 49.32% (2022-23), 50.26% (2021-2022), 50.04% (2020-2021), 48.93% (2019-2020), 47.88% (2018-2019) female students in the college. A good percentage of staff of the college are females including the IQAC Coordinator(s) and Convenors of different Cells/Sub-Committees. Gender Sensitization Programmes are regularly organized by different cells/sub-committees under the guidance of IQAC.

Courses on Gender Equity and Gender Sensitization are incorported in the curriculum of the Under Graduate Programmes. Topics like Women's Writings, Social Inequality, Population Education, Women Education, etc are included in the syllabi of English, Philosophy and Education at UG level which gives a thorough understanding of issues on gender equity to the students.

The institution provides the following facilities for the women on campus:

i) 24X7 CCTV Surveillance System and Security Guards for ensuring safety and security of the girl students in campus.

The initiatives taken by these units involve student participation in terms of their voluntary engagement in social service. These activities give them an opportunity to engage themselves in community service thereby contributing to their holistic development and instilling in them a sense of social service.
